Estate Planning — Joan Grimes

Joan Grimes was our guest speaker today, and also a fellow Rotarian from the Alamo Club. Joan is from Lafayette, CA, and attended UC Berkeley and Cal Western School of Law in San



Diego. She is lawyer with offices located in Walnut Creek and Brentwood.

Joan's presentation was about why it is important to have a trust. When our parents were living, a simple will was all that was needed. Mom left everything to dad, and dad left everything to mom. And after they both had passed, their heirs got to figure everything out. In the 1970's, laws were enacted to allow people to have a revocable living trust. A trust is simply a conduit where you place everything. You still own everything, but all assets are placed in the trust. Your assets still benefit you during your lifetime and can then be transferred to designated beneficiaries at the time of your death. Having a trust will make the process of passing your estate to your loved ones easier. Living trusts avoid the probate process, which can be expensive, time consuming, and your loved ones have no control over the process. A living trust allows you to control all of our assets, and prevents the court from controlling your assets if you become incapacitated. Even with a trust, you still need a will which would "catch" anything that you had failed to place in the trust.
